We use necessary cookies to ensure our websites work correctly. These cookies are strictly necessary for the operation of our websites. We also use optional cookies for performance and functionality purposes. These cookies are inactive for the duration of your visit unless you choose to specifically enable them using the options in cookie preferences. These optional cookies collect information in an anonymous way and you cannot be identified as an individual through the data we collect.

Our **main website** uses the following types of cookies:

Category	Cookie Name	Purpose
Necessary	PHPSESSID	This cookie is native to PHP applications. The cookie is used to store and identify a users' unique session ID for the purpose of managing user session on the website. The cookie is a session cookies and is deleted when all the browser windows are closed.
	ASP.NET_SessionId	Issued by Microsoft's ASP.NET Application, this cookie stores session data during a user's website visit.
	Cookieyes-consent	CookieYes sets this cookie to remember users' consent preferences so that their preferences are respected on their subsequent visits to this site. It does not collect or store any personal information of the site visitors.
	ARRAffinitySameSite	This cookie is set by Windows Azure cloud and is used for load balancing to make sure the visitor page requests are routed to the same server in any browsing session.
	ARRAffinity	ARRAffinity cookie is set by Azure app service and allows the service to choose the right instance established by a user to deliver subsequent requests made by that user.
	Crumb	Squarespace sets this cookie to prevent cross-site request forgery (CSRF).
Analytics	_ga	The _ga cookie, installed by Google Analytics, calculates visitor, session and campaign data and also keeps track of site usage for the site's analytics report. The cookie stores information anonymously and assigns a randomly generated number to recognise unique visitors.
	_gid	Installed by Google Analytics, _gid cookie stores information on how visitors use a website, while also creating an analytics report of the website's performance. Some of the data that are collected include the number of visitors, their source, and the pages they visit anonymously.
	_gat_gtag_UA_109426662_1	Set by Google to distinguish users.
	CONSENT	YouTube sets this cookie via embedded youtube-videos and registers anonymous statistical data.

Advertisement	YSC	YSC cookie is set by Youtube and is used to track the views of embedded videos on Youtube pages.
	VISITOR_INFO1_LIVE	A cookie set by YouTube to measure bandwidth that determines whether the user gets the new or old player interface.

These cookies store encrypted information that enable the site to recognise the user for the period of their session.

Cookies in emails
